Credentials are not required to enter the Fairgrounds. Entrants drive to their respective exhibit building, enter items, and leave to accommodate others

Exhibit Entry:

- Friday, August 1, 11 am – 7 pm
- Saturday, August 2, 11 am – 7 pm

Exhibit Pick-up:

- Tuesday, September 2, 1 pm – 6 pm
- Saturday, September 6, 1 pm – 6 pm

Contact superintendent if unable to bring entries on Entry Day. Special arrangements may be requested. Mail in entries are highly encouraged.

Entries without entrant contact/mailing information will be automatically disqualified and not judged.

Sub-Categories:

- O: Open
- P: Professional

If sub-category is not specified, entry will be classified as OPEN.

REQUIREMENTS / RESTRICTIONS

- Entrants for Division 01 - 08 must be 21 years of age or older.
 - Exhibitors may enter only once per Class. Please enter as many Classes as you have an entry for.
 - Entries must be in the standard glass minimum = 12 ounce bottles with bottle caps or cork tops. (*No screw tops*) Bottles may be any color or shape, providing an air tight seal.
 - No plastic containers, pop bottles, or food jars will be accepted.
 - Glass bottles are preferred.
 - Federal laws prohibit distilled entries.
 - Score sheets will be returned with bottles on pick-up day.
 - **If you do not want your bottles, your score sheets & ribbons may be mailed after the Fair. This service must be requested on Entry Day by providing a prepaid envelope with your entry.**
 - Superintendent has the right to refuse an entry due to health or safety concerns. (*Only enter samples you would serve to your family & friends.*)
 - All unclaimed bottles and contents become fair property.

DIVISION 01: WINES

Fermented from grape or other juices.

Enter minimum volume of 750 ml – Total Volume

DIVISION 02: FLAVORED SPIRITS & LIQUEURS

Distilled spirits that have flavoring and sugar or syrups added.

Enter minimum volume of 750 ml – Total Volume

- 01 Liqueur Berry & Fruit
 - 02 Liqueur Other
 - 03 Liqueur Cream, Berry/Fruit
 - 04 Liqueur Cream, Chocolate
 - 05 Liqueur, Coffee
 - 06 Other

DIVISION 03: MISCELLANEOUS SPIRITS

Enter minimum volume of 750 ml – Total Volume

DIVISION 04: Beer

Ales = Malt extracts fermented with Ale Yeast >3.2% ABV

Lagers = Malt extracts fermented with Lager Yeast >3.2% ABV

Enter minimum volume 3 x 12 oz. = 36 oz. Full Volume

DIVISION 05: MEADS AND CIDERS

Meads = Alcoholic beverages fermented with honey.

Cider = Alcoholic beverages fermented with fruit juices.

Enter minimum volume 3 x 12 oz. = 36 oz. Full Volume

- 02 Mead, Sweet
- 03 Mead, Fruit (Melomel)
- 04 Mead, Other
- 05 Cider
- 06 Cider, Hard
- 07 Cider, Other

DIVISION 06: NON-ALCOHOLIC BEVERAGES

Craft beverages under .25% ABV (Alcohol By Volume)

*Soda is defined as **Brewed** Sodas, i.e. Root Beer, Orange Cream Soda.*

Syrups for Seltzer Mixes are no longer accepted

Sub-Categories:

If sub-category is not specified, entry will be classified as OPEN.

- A: Junior, ages 8 and under
- B: Junior, ages 9 through 13
- C: Junior ages 14 through 17
- P: Professional

Minimum volume 3 x 12 oz. = 36 oz. Total Volume

Class:

- 01 Soda, Berry & Fruit
- 02 Soda, Cola
- 03 Soda, Other
- 04 Root Beer
- 05 Sarsaparilla
- 06 Ginger Beer
- 07 Non-Alcoholic Beer (> .25% ABV)
- 08 Kombucha, Berry/Fruit
- 09 Kombucha, Spice/Herb
- 10 Kombucha, Other

DIVISION 07 - CRAFT BEVERAGE LABEL COMPETITION

Requirements:

- Create your own original Craft Beverage Label.
- Labels will be no bigger than 4" x 5"
- Label must be printed on card stock or affixed to stiff paper. Artist information must be on the back of the paper, include: name, address, and phone number.
- Labels will be judged on originality, creativity, readability, etc.
